- E). The Counselor/Therapist used the wrong approaches, therapies, services, information, etc. Thus, the Counselor/Therapy didn't solve or rectify the person's problem, situation or issue.
- F). The Counselor/Therapist was too idealistic and not realistic or practical.
- G). The Counselor/Therapist lacked the necessary resources to help people.
- H). The person in question wasn't motivated to help themselves and improve their situation.
